"WHEREAS IT HAS BEEN MORE THAN TWO DECADES SINCE THE WESTRAY MINE DISASTER IN NOVA SCOTIA AND A DECADE SINCE AMENDMENTS WERE MADE TO THE CRIMINAL CODE OF CANADA TO HOLD CORPORATIONS, THEIR DIRECTORS AND EXECUTIVES CRIMINALLY ACCOUNTABLE FOR THE HEALTH AND SAFETY OF WORKSER; AND WHEREAS POLICE AND PROSECUTORS ARE NOT UTILIZING THE WESTRAY AMENDMENTS, AND NOT INVESTIGATING WORKPLACE **FATALITIES THROUGH THE LENS OF CRIMINAL** ACCOUNTABILITY; AND WHEREAS MORE THAN 1,000 WORKERS A YEAR ARE KILLED AT WORK; THEREFORE BE IT RESOLVED THAT THIS COUNCIL SUPPORT A CAMPAIGN TO URGE OUR PROVINCIAL GOVERNMENT TO ENSURE THAT: CROWN ATTORNEYS ARE EDUCATED, TRAINED AND DIRECTED TO APPLY THE WESTRAY AMENDMENTS; DEDICATED PROSECUTORS ARE GIVEN THE RESPONSIBILITY FOR HEALTH AND SAFETY **FATALITIES; POLICE ARE EDUCATED, TRAINED AND DIRECTED TO APPLY THE WESTRAY AMENDMENTS;**

(e) Retaining Wall Repair at Kinsey Drive

"ASK STAFF TO GET AN INDEPENDENT ENGINEER TO LOOK AT THE SITUATION AND COME BACK WITH A REPORT STATING WHY THIS OCCURRED; AND TO DO AN ANALYSIS OF ANY OTHER SIMILAR WALLS IN THAT DEVELOPMENT OF PINNACLE RIDGE; AND THAT WE ALSO ASK STAFF TO CONTACT THE DEVELOPERS OF PINNACLE RIDGE AND EXPRESS TO THEM OUR EXTREME CONCERN AND DISAPPOINTMENT AT HOW ONE OF THE STRUCTURES IN THEIR DEVELOPMENT HAS ALREADY FAILED AND THAT WE WOULD HAVE AN EXPECTATION THAT THEY SHOULD BE STEPPING UP AND CONTRIBUTING TO THE COST OF THE ENGINEERING ANALYSIS AND THE REPAIR."

11. NEW BUSINESS (CONTINUED)

(f) Outdoor Fitness Recreation Centre

R153/2014 It was MOVED and SECONDED:

"THAT WE ASK THAT THE PARKS AND RECREATION COMMITEES TO MEET TO COLLABORATE ON THE DECISION AS TO WHETHER OR NOT DEVELOPING AN OUTDOOR GYM AND WASHROOM AND STORAGE AT THE SPIRIT PARK SITE IS A GOOD THING FOR THE VILLAGE TO PURSUE."

Council subsequently suggested that the staff report be provided to members, and advised that the Committees are not being asked to deal with the financial issues, but are being asked to address whether this is the right project for the park at this time.

(g) Summer Council Meeting Schedule

Council agreed to amend the Regular Council Meeting schedule for 2014 by: postponing the July 8 meeting to July 15; postponing the July 22 meeting to July 29; and cancelling the August 26 meeting. The August 12 meeting remains as scheduled.

Mayor Anderson reported that:

- She will attend a TransLink meeting on Thursday where they will discuss the 30-year vision of the transportation needs for each municipality.
- She will be attending a Metro Board meeting on Friday.
- She thanked Kevin Dicken and other public works staff for their quick response to a situation on East Road after a fallen tree caught on fire.

13. COUNCILLORS' REPORTS

Councillor Palmer Isaak reported that:

A Canada Day celebration will not take place in Anmore this year. The event was
cancelled due to low attendance in the last two years, and residents are encouraged
to attend a celebration in a neighbouring municipality. The Committee's efforts will
go toward an exceptional Ma Murray Day celebration.

13. COUNCILLORS' REPORTS (CONTINUED)

Councillor Thiele reported that:

- She attended a meeting with Coquitlam School District regarding traffic safety.
- She is hoping to speak with the Anmore Elementary School's new principal about a plan around traffic safety.

Councillor Green reported that:

- Several residents have formed a committee regarding bussing children to nearby elementary, middle and high schools as a service paid for by parents. Those interested should contact Belcarra resident Shelly Drysdale, who is starting to organize pick up / drop off stops.
- A plan needs to be discussed and implemented regarding traffic safety prior to any issues that may come about, before the start of the new school year.
- \$730,000 of the \$1.1 million required funds has been raised for the rebuild of the Mossom Creek Hatchery. The cost was significant due to the design of the building and the desire to put in an education centre. On July 13 at 6:00 to 9:30 p.m. a BBQ Gala is being held to raise more money.

14. CHIEF ADMINISTRATIVE OFFICER'S REPORT

Tim Harris reported that:

- He attended a LGMA Approving Officer Workshop.
- He met with the BC Hydro warden to discuss the beginning stages of the emergency evacuation plan.
- A sports field with an adjoining basketball court will be built at Eagle Mountain Middle School.
