# 4. MAYOR McEWEN'S INAUGURAL ADDRESS

I would also like to thank staff and our consultants for their continuing effort and passion for our community. I look forward to listening and working with you all.

I would like to extend a very warm welcome to all newly elected Councillors. Unfortunately newly elected Councillor Trowbridge couldn't join us due to previous commitments, yet will be sworn in next Tuesday, December  $9^{th}$ .

With being on Council for the past six years and having a good understanding of the challenges our community faces, it's extremely comforting having (which I believe) is such an eager and diverse group on this Council to address issues with a balance approach.

Over the coming months Council Members will undergo basic training through various resources, which in turn will bring everyone up to speed relating to the operation and current issues facing the Village.

I am hoping with Council's support to immediately revamp our communication strategy which in turn will hopefully provide greater engagement, accountability, and transparency throughout our community.

I would also like to review our procedural bylaw with Staff and Council in hopes of streamlining the political process. An example of this yet not limited too would be; ensuring timely/expanded minutes, as well as action items included within all council and committee agendas.
