A bylaw to amend Anmore Parking Regulation and Enforcement Bylaw No. 308-2001

**WHEREAS** it is deemed expedient to amend Parking Regulation and Enforcement Bylaw No. 308-2001.

**NOW THEREFORE** the Municipal Council of the Village of Anmore, in open meeting assembled, enacts as follows:

1. That this bylaw may be cited for all purposes as “**Anmore Parking Regulation and Enforcement Bylaw Amendment No. 603-2019**”.
2. That Anmore Parking Regulation and Enforcement Bylaw No. 308-2001 be amended as follows:
  - (a) That the Section following Section 3. DEFINITIONS be renumbered to Section 4 and that each subsequent Section be renumbered accordingly.
  - (b) To add the words in Section 4 “and forming part of” after the words “Schedule “A” appended to”.
  - (c) To add the words in Section 8 “outstanding penalties levied by the Village, and” after the words “by paying the” and to update the reference to Section 5 to reference the renumbered Section 7.
  - (d) To delete “Schedule A” and replace it with “Schedule A” attached to and forming part of this bylaw.

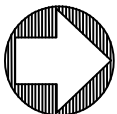

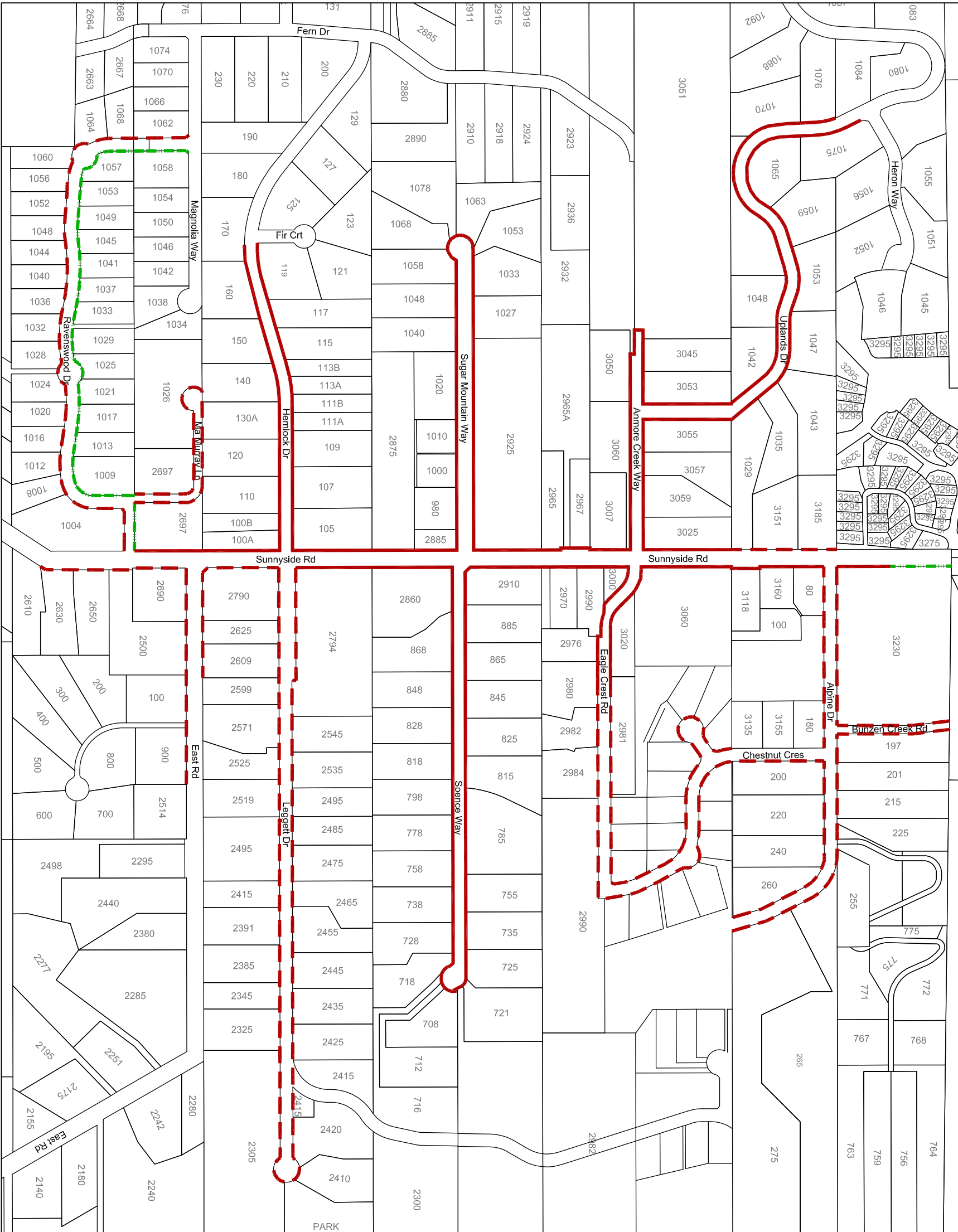

A bylaw to amend Anmore Municipal Ticket Information Utilization Bylaw No. 479-2009

**WHEREAS** it is deemed expedient to amend Anmore Municipal Ticket Information Utilization Bylaw No. 479-2009

**NOW THEREFORE** the Municipal Council of the Village of Anmore, in open meeting assembled, enacts as follows:

1. That this bylaw may be cited for all purposes as “**Anmore Municipal Ticket Information Utilization Amendment Bylaw No. 604-2019**”.
2. That Anmore Municipal Ticket Information Utilization Bylaw No. 479-2009 be amended as follows:
  - (a) That Section 3 be amended to add the words “which forms part of this bylaw” after the words “Schedule 1”
  - (b) That Section 5 be amended to delete the words “Schedules 2 through 9 attached to this bylaw” and replace it with the words “Schedules 2 through 10 attached to and forming part this bylaw”.
  - (c) That Section 6 be amended to add the words “and Column 4” after the words “Column 3” delete the words “Schedules 2 through 9 attached to this bylaw” and replace it with the words “Schedules 2 through 10 attached to and forming part of this bylaw”.
  - (d) To delete row 5 of Schedule 1 and to replace it with the following:
