I question why there is the feeling this is so time-sensitive that it is posed as almost a 'now-or-never' approach? It does not rule out the ability to change the designation in the future entirely, though I realize with different hurdles in the future. I am curious what our economic growth would look like as rural versus urban when we don't even have a clear plan for how we would utilize an urban designation- how are you quantifying the differences clearly?

Also, why is it being suggested to be a negative to require a higher level of buy in from Metro Vancouver board to agree to Anmore's potential development plans when our Village tries so heavily on other municipalities for services? And it is not a one way transaction either.

Why was there no clear information about how emails, Zoom feedback, etc. are being considered and reviewed? I feel this lacks transparency and only adds to frustration and confusion by other residents that I have seen engaging with the matter- myself included. It had been stated this survey would only be available to those attending Zoom, now it is being distributed. It is incredibly frustrating the lack of cohesion considering the magnitude of this decision. I've seen posts from the Mayor and councilman that minds are not made up, yet the rhetoric is we need to do this now, it is what has been recommended as the future of Anmore, etc. I would have appreciated a more balanced presentation that also focused on what it means to not embrace this in a more clear and delineated manner- the flyer sent out did not address this at all. There are pros and cons to both sides of urban versus rural for the Anmore South lands. And I feel it is not an inconsequential change to move to urban designation for this land. And maybe if both sides were argued more balanced, it would be a more favourable approach.

What does it mean we have more control if we go urban? How do we lose the position to be self-guiding? If staying rural is the want of the majority, that is self-guiding. If we are urban, yes plans need to be approved, but owners get to decide too whether they will build or not. This seems misleading.

Lastly, many people moved to Anmore and continue to live here because of the rural designation, myself and my family included. This is not a surprise to folks who choose to come here and is part of what it means to live here. For me, it is the rural nature of Anmore that makes living here so unique and wonderful. It is not an opportunity and living experience easily found in the lower mainland and to lose it would be shameful. Particularly the lack of light and noise pollution. Regardless if council is pushing urbanization to avoid the RGS, or potentially allowing for denser development, it is frustrating to agree to a change that leaves too many doors open that radically change our way of living in this area in the future. While I appreciate there is more options that we haven't decided upon, I believe it is the apprehension that this could turn into something the majority of residents may not want too easily, to be part of the hesitation. It is definitely part of my own. I am strongly against any mass buildings/towers/etc., and this is a possibility that cannot be ruled out once the change is made to urban, and I don't trust that with the motivation for funds would not override looking for creative or other solutions to build growth in our Village down the line.

As Doug Rischarson pointed out (AAND THAT YOU SHOULD INFORM THE PUBLIC ABOUT) whether 50% plus one or 75% plus one, in either case based on vote numbers oat the municipal level, you will need to convicne Vancouver and Surrey who, in either case, are needed to be on side. THERE IS NO LOGIC TO RUSHING THE PROCESS!!! You can get it done anytime in the future with those two munis on board.

I see control as better under RURAL BECAUSE IT ALSO CONTROLS ROGUE COUNCILS NOW AND IN FUTURE WITH OVERSIGHT BY OTHER MUNICIPALITIES TO VOTE ON ANY DRASTIC CHANGES. While you see that type of control as "too restrictive" under RURAL, you ask us to trust your position being best and rushing to your desired result despite it being contrary to my and many others' points of view governed under Rural process.

Unless or until you can address my (and many others') concerns regarding the freedom for development that Urban would then give Council and the Mayor (under whom the current and one past Council with the same Mayor have proven repeatedly not to engage referendums NOR to give the majority of citizens a voice other than through closed door surveys), this Council and Mayor who act as the executive branch of the public service have not garnered a level of trust that is deserved. Your long term goals for our Village appear to directly conflict with mine and many many other residents who seek NO COMMERCIAL DEVELOPMENT and who all desire the Rural aspects of current CD ZONING controls required with GREEN SPACE ALLOTMENT as a good thing not a "problem to solve" (as you see it).

While you state Urban designation does not change RS 1 acre zoning, I am NOT confident over the process of insuring that 1 Acre RS type zoning would remain under Urban 1 acre zoning with this or any future council. You leave all of us with a feeling of a hidden agenda seeking commercial development and high rises (which you Mayor McEwan were quite ready to embrace when first proposed) only to have that suddenly disappear to have this Urban designation crop up. Is this an unbiased review process to gain the understanding of the majority of Anmore citizens to seek their desired best future? Don't make me laugh.

Do you want to know what I see? I see a Council working with the developer who both see the same thing - a commercial multi residential area despite it being accessible with a single 2 lane ring road of residential streets.

I see Council and the developer not doing their infrastructure homework in logistics. I see you both reintroducing the same if not even more residential high rises and commercial development despite NO ADEQUATE ROAD ACCESS with an Urban designation pushed through (assuming you do). I see the developer returning to the table with the same if not higher density proposals which you and Council will end up changing the 1 acre zoning to allow without any oversight by other municipalities nor by the control of the citizens of the Village through public debate and forced referendum.

I have a concern witnessing a theft of our natural heritage, respect for the rural perspective and protective covenants and the destruction of our residential dark skies policy.

I have an important consideration in you Mr McEwan who repeatedly act as the point man for this apparent travesty. Your vision and the support you have garnered to push it through with just two of your other friends on Council that are subservient to your wishes is at odds with mine unless you can convince me and other concerned citizens with the same concerns otherwise.

So you must decide if we are at an impasse unless you can clarify your points to meet my thoughts on the matter or willing to put this to public review process in a referendum.

At no time has this Council or the Mayor publicly addressed the dangerous infrastructure logistics with a lack of adequate safe access by public roadways into and out of the site in question. At no time has this Council or Mayor addressed the end result of extra lights and cross walks on our ring roadway structure (East Rd-Sunnyside- First Ave- loco ring road) nor the related destruction of Anmore's dark sky policy in the change of designation and their lack of concern for how "urbanization" designation in this area will affect that.

- 1) answers to the question of the roadway network ring road logistics and planning
- 2) answers to the question of what will happen with Anmore's current rural dark sky policy under urban development of this area and its effects on the rest of the Village.

You have only focused on benefits that Council sees as just. Until Council addresses honest issues of drawbacks and the failure in the procedure to disseminate the information and gather detailed responses as being inadequate to date, I do not trust this Council's and the Mayor's advice nor their lack of regard to the process.

This Council has failed to convince many very informed and concerned citizens - which include prior council members and political appointees over time that now sit as the "Village elders council" so to speak - of their concept that Urban designation in this area is "a good thing" as they repeatedly try to convince the Village of.

We are not speaking of citizens that are ill informed of how the political and municipal processes work or of uneducated people. These are in no small part the most informed and seasoned people both in Council procedures and in understanding municipal designations in the Village that pose serious concerns to what this current Council is currently entertaining.

I am deeply concerned that there has been no public addressing by Council of the concerns regarding the obvious traffic problems with the giant Anmore Village ring road network into and out of the Anmore South area should this area become more high density eventually under urban designation. The fact that the Council is convinced that urbanization in this area is important despite never looking into honestly addressing these roadway concerns is both alarming and concerning. It isn't just about plumbing.

I do not trust the process being undertaken by this council and mayor and seek a level of trust. They have repeatedly enacted gross malfeasance to the process of tabling referendums on important topics deserving such concern. Their procedure in gaining public input is not transparent and trust is severely lost over time.

When the results of surveys like this one are not made public whenever they indicate a majority against this Council's desired goal, it belies deceit and that is untenable.

Convince me otherwise. Let the process be fully transparent. I ask the Village display in public on the website of Anmore the results of this or any future survey of this topic and to enact a non-binding questionnaire simply asking the people their public choice for or against urban designation once the Council feels adequate information has been disseminated to the people.

If the Council goes against the majority of the survey and non-binding questionnaire, we know where this council and Mayor stands in the next election.
