These changes reflect revised land uses based on the proposed **Anmore South Neighbourhood Plan**, which is intended to be integrated into the OCP. The bylaw also includes updates to related OCP policies and the Anmore Regional Context Statement to ensure alignment with the broader goals and objectives of the Official Community Plan.

The purpose of this amendment is to support the development of **2,202 dwelling units**, including 8 single-family detached homes, 120 duplex units, 740 townhomes and 1,334 apartments.

The proposed vision also includes opportunities for small-scale commercial uses (e.g., a local grocery store, shops, and services) and community amenities such as parks, trails, natural areas, and recreation facilities.

To accommodate this vision, the land use designation for the Anmore South Lands would be changed from Hillside Residential to Anmore South Neighbourhood Plan, enabling the following land uses:

The purpose of the Proposed Bylaw is to amend the existing Official Community Plan Bylaw No. 532-2014 (the "OCP") to include the Anmore South Neighbourhood Plan as a new chapter forthe area identified as Anmore South as shown onthe attached map. In addition, the OCP is amended by incorporating multiple text and policy changes, revisions to the Regional Context Statement, and changes to mapping schedules for consistency with the Neighbourhood Plan. These changes relate to lands both within and outside of the regional urban containment boundary within the Village.


The Neighbourhood Plan envisions a future mixed-use development with 1,750 dwelling units, including:

- 20 single family;
- 120 duplex units;
- 960 multi-family/townhome units; and
- 650 residential and mixed-use apartments




The proposed vision also includes opportunities for small-scale commercial uses and community amenities such as parks, trails, natural areas, and recreation facilities.

To accommodate this vision, the OCP land use designation for the Anmore South lands would be changed from Hillside Residential to Anmore South Neighbourhood Plan, enabling the following land uses:



The Anmore South lands are outlined in a bold black line on the image below and are legally described as follows:
