2026 GENERAL LOCAL ELECTIONS

PUBLIC NOTICE IS HEREBY GIVEN AS FOLLOWS:

ADVANCE ELECTOR REGISTRATION

The close of advance registration for the Anmore General Local Election is August 25, 2026.

Are you eligible to vote in the Anmore General Local Election for Mayor, Councillors and School Trustee? Is your name on the current list of electors?

If you are not sure you can find out by visiting [Register to Vote | Elections BC](https://www.elections.bc.ca/register-to-vote), or calling 1-800-661-8683 or by emailing voterservices@elections.bc.ca

The Village of Anmore will be using the Provincial Voters List. Advance elector registrations will be accepted at Elections BC office until August 25, 2026, Elector registrations will not be accepted during the period August 26 to October 17, 2026, but will be accepted on voting days.

ELECTOR QUALIFICATIONS

RESIDENT ELECTORS:

- 18 years of age or older on general voting day for the election or assent voting; and
- a Canadian citizen; and
- a resident of British Columbia for at least 6 months immediately before the day of registration; and
- a resident of the municipality; and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

NON-RESIDENT PROPERTY ELECTORS:

- 18 years of age or older on general voting day for the election or assent voting; and
- a Canadian citizen; and
- a resident of British Columbia for at least 6 months immediately before the day of registration; and
- a registered owner of real property in the municipality for at least 30 days immediately before the day of registration; and

- the only persons who are registered owners of the property, either as joint tenants or tenants in common, are individuals who are not holding the property in trust for a corporation or another trust; and
- not entitled to register as a resident elector; and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and not otherwise disqualified by law; and
- **if there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non-resident property elector.**

LIST OF REGISTERED ELECTORS

Beginning September 1, 2026 until the close of general voting for the election on October 17, 2026, a copy of the list of registered electors will be available for public inspection, at the Anmore Village office - 2697 Sunnyside Road, Anmore, Hours of Operation: Monday – Friday 8:30 a.m. to 4:00 p.m. (closed stat holidays). It would be helpful to call ahead if you are coming to view the list 604-830-1897, or email Elections@anmore.com

Before inspecting the list, a person must sign a statement that they will not inspect the list, make copies, or use the information included in the list except for the purposes of Part 3 – Electors and Elections of the *Local Government Act*.

REQUEST TO OMIT OR OBSCURE

An elector may request that their address or other personal information about them be omitted from or obscured on the list of electors. The elector must contact the Chief Election Officer or the Deputy Election Officer to make this request before August 31, 2026.

OBJECTION TO REGISTRATION OF AN ELECTOR

An objection to the registration of a person whose name appears on the list of registered electors may be made in accordance with the *Local Government Act* until 4:00 pm on Friday, September 11, 2026. An objection must be in writing and an objection may only be made by a person entitled to be registered as an elector of the municipality and only on the basis that a

person whose name appears on the list of electors has died or is not qualified to register as an elector of the municipality.

Important: Candidates submitting nomination forms must have their signature witnessed by a Commissioner for Taking Affidavits. The Chief Election Officer or Deputy Chief Election Officer can witness your signature if you bring in your forms in person. We HIGHLY recommend you call ahead to make an appointment. It will take about 30 minutes to go through all your forms and make sure everything is correctly submitted. We cannot accept nomination forms that are NOT complete. If you plan to courier nomination documents, email, or submit after hours, make sure your signature is witnessed by a notary public, lawyer or other individual registered as a Commissioner for Taking Affidavits.	

Interested persons can obtain information on the requirements and procedures for making nominations, including nomination forms at the Anmore Village Hall, Coquitlam School

District for Trustees only, nomination documents are also available from the website [2026 Election - Village of Anmore](#) from August 5, 2026 to September 11, 2026 at 4 pm.

QUALIFICATIONS FOR LOCAL GOVERNMENT OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day October 17, 2026;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed, September 11 at the latest;
- not disqualified under the *Local Government Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

QUALIFICATIONS FOR SCHOOL TRUSTEE

A person is qualified to be nominated, elected, and to hold office as a School Trustee if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day October 17, 2026;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed September 11, 2026; and
- not disqualified under the *School Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding office as a trustee, or be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general local election, the following expense limits for candidates during the campaign period apply: (also see [Candidate Expense Limits | Elections BC](#))
